The General Directorate of Mersin Water and Wastewater Administration (MESKİ), delegation of the European Union Facility for Refugees in Turkey (FRIT 2), within the scope of the Municipal Services Project-I, is planning to tender "Mersin Erdemli District Tömük WWTP and Sea Outfall Project" within the frame of AFD tender procedures and methods, from the fund given by the Agence Française de Développement (AFD) with the section provided through ILBANK.

## **Dectription of Works**

The works covered under this contract includes the construction of a new wastewater treatment plant (WWTP) for Tömük and Arpaçbahşiş within the border of allocated WWTP area and construction of deep-sea discharge (i.e. sea outfall) line to the receiving body.

(Mersin) Erdemli Wastewater Treatment Plant shall be a sequential batch plant (SBR) for nitrogen and phosphorus removal (Sequential Batch Reactor (SBR)) Sludge stabilization can be achieved within the SBR tanks using extended aeration.

Works under this contract consist of complete engineering design and construction, civil, mechanical and electrical works, start-up of the project, its commissioning, operational training of the end recipient's personnel and handing-over of a complete wastewater treatment plant and a deep-sea outfall ready for operation, to MESKİ, in the place within the border of allocated WWTP area.

The Employer reserves the right to require changes to the scope of the Works by altering, adding to or deducting from the Description of Works, such changes to be within the Bidding Documents for Procurement of Works.

The Employer intends to initially select a maximum of 6 firms for **Erdemli District Tömük WWTP and Sea Outfall Project** (Design and Build). It is expected that invitations for bid will be made in March 2025.
